July 25-28 the 38th UAW Constitutional Convention was held in Detroit. In accordance with the results of the UAW Referendum held in the fall of 2021, the International Officers of the UAW will no longer be elected by Convention delegates, but rather through Union-wide direct elections in which UAW members will cast votes directly for nominated Candidates. The 2022 UAW International Officer Election will be conducted by secret, mail-in ballot in the fall of 2022. The offices to be filled through the election are President, International Secretary Treasurer, three (3) International Vice Presidents, and nine (9) Regional Directors The nominations for these positions were made at the 38<sup>th</sup> Constitutional Convention

The Direct Voting System was passed with just 14% of our members voting last fall.

#### Did you receive your ballot last fall? Do you know a Retiree who didn't?

There were thousands of returned ballots that were un-deliverable for this election; you need to update your mailing address with your local Union. Your address cannot be shared by the Medical Benefit Trust or the company you retired from with the UAW Retired Workers Department. Only open Locals can update your address. If your Local is closed, or you are not sure send us an email: <u>SVUAW@AOL.COM</u>. Your name, DOB and last 4 of SS# will be needed. If your Local is open a phone number will be supplied to you, if it's closed your address information will be passed on to the Retiree Dept.

This election is very important for UAW Retirees. Who you elect can quite possibly affect your benefits, and our retiree structure. We have great benefits through our UAW Medical Benefits Trust. "Did you know that the UAW IEB appoints five members of the board of the VEBA?" They along with the independent (non-UAW) members of that board, decide what our benefits will be. The existence of our Retiree Councils, and our Drop-in Centers are determined by our International Officers. We presently have dedicated Regional Retiree Representatives that attend our meetings and assist our retirees. All of these are issues for retirees to consider when they vote.

You must fill out a new card to increase your dues from \$2 to \$3.
